NJ TDB Benefit Provision Enhancements

Partial Disability Benefits (effective June 17, 2020)

Up to 8 weeks, unless medically warranted, then up to 12 weeks

- Eligibility Requirements:
 - Employer must be agreeable
 - Employee must have been totally disabled for at least 7 days
 - Physician must confirm employee's ability to return to work on a reduced work schedule

Job Protection / Non-Retaliation Provision

Job protection provisions under the Family Leave Act are extended employees under NJ TDB law, businesses with 30 or more employees. Employers are now prohibited from any means of retaliation against an employee after a period of temporary disability or family leave.
